2. By-Laws & Responsibility Grid

The group reviewed and approved the Site Council By-Laws and Responsibility Grid. 3. Stakeholder Group Reports

Admin:

- **New Building Updates** All things considered, the opening has gone well. There are still lots of bugs to work out, but overall the building is functioning well.
- Enrollment/Staffing Updates Howard has come in over our enrollment projection by about 60 students and have had 1.75 FTE added to our building this year, so that we now have three teachers as all grade levels. Howard is now the fourth largest elementary school in 4J and is actually larger than every middle school in 4J except for Roosevelt, Cal Young and Monroe.
- Free Meals Howard and three other 4J schools now offer free meals to all students, which makes it so families no longer have to fill out free/reduced meal forms and students don't need to type in their PIN numbers at breakfast or lunch.

- Cookie Dough Fundraiser The cookie dough fundraiser kicked off last week. All orders are due Wednesday, Oct. 5th. Orders can be placed online.
- Future Fundraisers The PTO is planning a spaghetti feed Friday, Nov. 4th. The Holiday Bazaar will be Nov. 19th and will be adding food carts this year.

Licensed Staff:

 Technology Issues – It's been very frustrating to be the Technology Immersion school but have so many technological issues in the new building; problems with the interactive white boards being the major one. Another major issue is projectors having problems competing with all of the natural light and not being bright enough.

Classified Staff:

 Working Hard – Besides working hard, there have been issues with badges not opening the courtyard gates.
